#### MINUTES OF THE REGULAR MEETING OF THE CITY COUNCIL OF THE CITY OF BLYTHEVILLE, ARKANSAS October 15, 2019 – 5:00 P.M.

The City Council of the City of Blytheville, Arkansas met in regular session at its regular meeting place in the Municipal Courtroom at 5:00 p.m. October 15, 2019. Present were City Clerk Connie Mosley-Brents, City Attorney Chris Brown and the following Council Members: Vera James, Barbara McAdoo-Brothers, Matt Perrin, John Musgraves and R. L. Jones. Council Member John Mayberry arrived late. Jonet' Washington represented the press.

The invocation was given by Pastor Danny Pankey.

Following the invocation, everyone was asked to remain standing for the Pledge of Allegiance.

Mayor Sanders asked for the Council's wishes for approval of the minutes from the September 17, 2019 regular meeting. Jones moved, Musgraves second, and by consent of all members present (6/0), the minutes of the September 17, 2019 regular meeting were approved, accepted and filed as prepared by the City Clerk.

Mayor Sanders asked for the Council's approval to amend the agenda due to the addition of a Resolution to accept the bid offered by Nibco Inc. for the sale of the Regal-Beloit building (formerly known as Magnetec). Jones made a motion to amend the agenda, Musgraves second, and by consent of all members present (6/0), the agenda was amended.

Mayor Sanders called for any person(s) wishing to speak on agenda items to come forward. There were none.

Mayor Sanders asked for Committee reports.

#### **POLICE AND FIRE** – Barbara McAdoo-Brothers

Committee met October 8, 2019:

**Fire Report:** BFD was recently awarded the Walmart Community Grant for \$2,000.00 to be used toward the purchase of fire prevention and life safety materials for the community. They have competed their annual hose testing to maintain the city's ISO class 3 rating. Pump testing will begin soon. Currently they are preparing for a confined space rescue training drill at the Dell Power Plant. The department recently participated in a training drill at Air Liquide, the scenario pertained to a mock fire of a liquid 02 pump on fire. Annual business inspections for 2019 are approximately 90% complete and no major violations have been found.

**Police Report:** Department is staffed at 29 officers. Six non-certified candidates and two certified candidates are in the process. The 2020 budgets for Police, Animal Control and Code Enforcement are almost complete. The department recently received approximately \$22,000.00 for the 2017 and 2018 JAG grants to go toward the purchase of tasers and forensic equipment. Officers completed night-fire exercises. In addition, the department has been busy with community events such as

football games, Main Street events and two 5k runs. Pafford reported they had 675 patient calls for the entire county for the month, 348 transports.

Director Cody Wyatt proposed to the committee to take \$10-\$15K from the Parks C.D. to fund an assessment from Revival Architecture to find any and all issues of the Ritz and a plan of repairs to apply for the 2020 grant cycle of from Arkansas Historic Preservation.

- More discussion about the geese issue in Walker Park, Jones asked that we try more scare
  tactics before deciding to purchase a trained dog. Audience member, Susie Langston,
  mentioned that some local hunters might have an already trained dog that could help us
  with our problem and we will be exploring that option.
- Wyatt also mentioned that she included \$6K into the Parks budget for 2020 to repair the lighting at the tennis courts.

At the Council meeting, Jones invited Delta Gateway Museum Director Leslie Hester to address the council. She gave a report of the scheduled upcoming events for the museum.

#### **AIRPORT AND UTILITIES** – Vera James

Committee met October 7, 2019. No one from the Airport Commission was present, however Mayor Sanders gave an update on the damaged lights at the airport stating the engineer has looked at the lights and the damage is significant. They will need to be replaced/repaired, especially for night time landing. A plan is being developed with Public Works to avoid this type of damage in the future. Wastewater Superintendent Gary Carr reported for September there were 117 locates, 5 emergencies and 17 service calls. He also reported the work has been completed on 9th and 11th Street and the asphalt company will be in the week of either Oct 7th or 14th to do their part. Carr reported the blowers at the West and South treatment plants have burned up and have to be replaced. Costs for the West is \$4,357.85 and the South is \$7,689.95. The West plant will be removed and a solarfield put in at the South plant at a savings of \$25,000.00 per year for 5 years. Mr. Brad Wingfield an engineer from PMI will do the design and get bids for the work. All fire hydrants will be checked and painted.

#### **CODE ENFORCEMENT & ANIMAL CONTROL** – John Mayberry

#### **FINANCE AND PURCHASING** – John Musgraves

Committee met October 8, 2019 and voted on the yearly millage tax – leaving it at 4 mills instead of increasing it. They heard from Tameka Jenkins of the Great River Economic Development Foundation requesting the city endorse two local businesses, Atlas Tube and FrigorTec, to participate in the tax back program. She asked that the city pass resolutions for such, and in addition, pass resolutions necessary for Atlas Tube to receive a block grant through the AR Economic Development Program project. The city will serve as the grant administrator. Committee voted to authorize bidding for alarm systems currently installed in city buildings, and in addition the committee voted to amend the budget for city parks and pools.

A special Finance Committee meeting was held on October 15,2019 to accept the bid offered by Nibco Inc. for the sale of the Regal-Beloit building (formerly known as Magnetec). Nibco Inc. bid \$701,101.00.

The Mayor called for new business.
