8.0 FIELD OPERATIONS

8.10 RIDE ALONG

8.10.1 PURPOSE:

The purpose of this policy is to set forth the department's mandates with respect to citizen ride-along and civilian passengers (Sworn Police Officers are exempt from this policy). Officers of this department are prohibited from transporting civilian passengers unless such transportation is in the ordinary course of their law enforcement duties, in compliance with this policy, or otherwise approved by the Chief of Police or their designee.)

8.10.2 POLICY:

It is the policy of this department to establish a ride-along program in an effort to enhance the mutual respect of police officers and the community. This program will provide its participants with a greater understanding of law enforcement in our community.

8.10.3 ELIGIBLE PARTICIPANTS:

Who can participate in the ride-along program:

- All participants must be approved by the Chief of Police or their designee and be at least 18 years of age or have guardian approval.

- All participants must complete an application and waiver of liability form.
- Media representatives must complete all documents required of any other participant. In addition, members of the media must have express written authorization from the Chief of Police or their designee before recording, by any means (audio, video, film, photo), any portion of the ride-along.

#### 8.10.4 APPLICATION PROCESS:

Applications and regulations for ride-alongs shall be available at the police department ([8.10 7-2013](#)). Applications, along with photo identification, must be returned to the department once they are completed.

- Completed applications shall be forwarded to the Chief of Police or their designee for review.
- Application review will include a record check and NCIC inquiry. An applicant who has a felony record or a misdemeanor record that involves moral turpitude or dishonesty may be excluded from participation in this program.
- Once approved, the applicant shall be notified and assigned a date for the ride-along.
- Participants shall only be allowed to participate in this program once every 12 months unless authorized by the Chief of Police or their designee.

#### 8.10.5 REPORTING FOR RIDE-ALONG:

The ride-along program shall be scheduled by the Chief of Police or their designee.

- Participants should report to the police department 15 minutes prior to their scheduled participation.
- The on-duty officer shall meet with the ride-along participant. If a liability waiver form has not already been signed, the ride along participant and the officer shall review and sign the liability waiver form. The officer must sign as a witness. Any participant who decides not to sign the liability waiver form shall not be allowed to participate in the program.
- The officer shall review the rules of the ride-along program with the participant. In this review, the participant should be reminded that they might be called as a witness in court, if they observe a police event that becomes subject to court action.
  - Officers shall list all ride-along participants who observe a police event as a witness on all arrest / incident reports.
- The officer shall issue the participant a “ride-along” participant identification tag that the participant shall be required to wear on his or her outermost clothing.

#### 8.10.6 DUTIES OF THE PARTICIPANT:

Participants must only act as an observer unless otherwise directed by their host-officer in an extreme emergency:

- Participants shall play no active role in the police function.
- Participants shall not be allowed to operate any police equipment
- Participants must remain in the police vehicle at all times

- Participants must not speak to victims, witnesses, prisoners or other persons associated with a police event. Should a witness, prisoner, victim or other person speak to the participant, the participant should politely direct the person to speak to one of the officers present.
- Participants shall not bring cameras or any recording devices without the express written permission of the Chief of Police or their designee.
- Participants shall not enter any person's home while participating in the ride-along unless the host officer has asked and has been granted express permission from the homeowner/occupant to allow the ride-along participant entry.
- Participants shall follow the instructions of the host-officer at all times during the ride-along.
- Participants shall not be allowed to carry any firearm or other weapon, even when otherwise authorized by law, while participating in the ride-along program.
- Participants should be dressed in comfortable, casual, but conservative clothing during the ride-along. (Pants and shirt/jacket for men, Pants and blouse/jacket for women) Participants who are inappropriately dressed shall not be allowed to participate in the program on the assigned date.

#### 8.107 DUTIES OF HOST OFFICER:

Host officers shall conduct their activities in a manner consistent with the efficiency of the police department as if the rider was not present.

- The host officer has complete discretion to determine the level of risk to the ride-along participant.
- The host officer has no duty to protect the ride-along participant beyond that of any other citizen.
- Officers should if possible attempt to avoid exposing ride-along participants to high risk activities such as but not limited to vehicle pursuits, execution of high-risk felony search/arrest and may consider dropping the ride-along participant in a safe area before proceeding.
- Host officers may distinguish civilians from news media, allowing the media to assume the risk of more dangerous activities.
- Host officers may allow the participant to leave the police vehicle in order to better observe the police activity; however, where a participant has been allowed to leave the police vehicle, host officers shall maintain close supervision of the participant and not allow the participant to involve him or herself in the police activity.
- Host officers must never allow a participant, including media, to enter the home of any person unless the officer has first obtained the consent of the homeowner/occupant. In obtaining consent the officer must specifically notify the homeowner/occupant that the participant is a "ride-along participant" and there is "no legal obligation" to allow the participant inside the dwelling.
