Also, Asst Ricky Jefferson w/Sky Cop he never got back w/ me on an answer. Now, I am hearing from Kim Sigman he didn't see anything even w/ witnesses

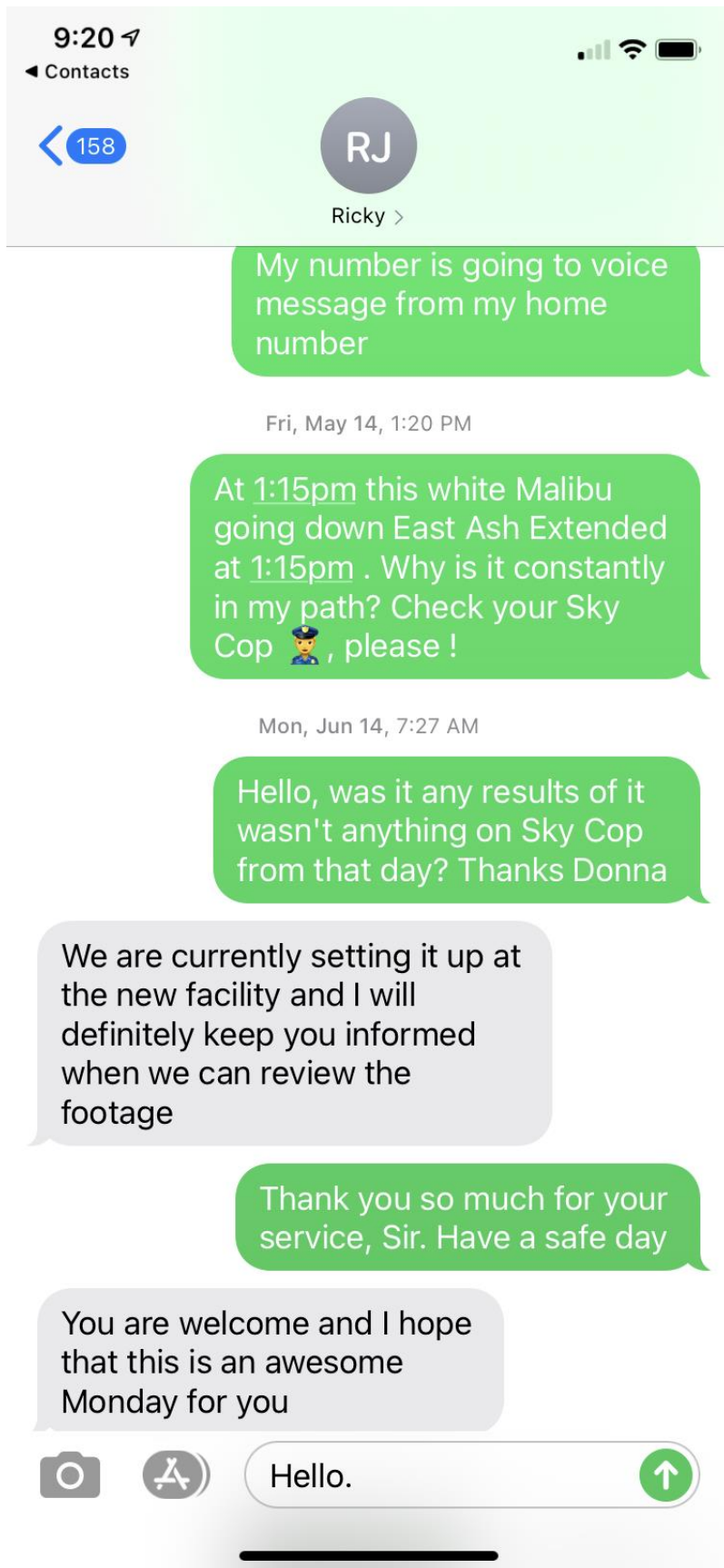
