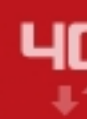


Chief Thompson:
