At approximately 2000 hours on September 29, 2018 I, Officer Driskill, responded to 910 Hearn regarding an unknown male knocking at the door trying to get in.

I made contact with the resident of 910 Hearn who stated that a black male in a blue shirt knocked on the door and was talking to her husband. The resident continued to state that the male tried to push his way into the house pass her husband. The resident also stated that he was acting strange and she believed him to be on something. While on scene, dispatch received several calls concerning a male matching the same description knocking on other doors on Walnut street.

I made contact with a caller on Walnut street who stated that the male kept knocking and was asking for help. The caller then directed me to 8th street where he was last seen. I was notified that dispatch received another call of a male screaming for help behind the Baptist Church.

I made contact with a black male in a blue shirt, later identified as Rayshawn Warren, who was walking up to a house on the southeast corner of Main and 7th. I attempted to talk to Warren and told him to come to me. Warren continued to walk away and yelled, "No!" Warren was told to come to me again, which he responded with another, "No!" and he began to run east on Main Street.

I caught up to Warren at Cobb Funeral Home, were I attempted to use an arm bar to restrain Warren. The move was ineffective and Warren ran across the street where I again caught up to him and tackled Warren to the ground

were I was able to restrain him until other officers arrived. When Officer Krupin and Officer Berumen arrived Warren continued to resist attempts to handcuff him. Officer Krupin administered drive stuns to the thighs and abdomen to Warren, which had no affect. After handcuffs were applied Warren continued to resist and began to kick at officers. During the altercation I injured my left ankle and sustained a busted upper lip. Pafford was notified for both Warren and myself.

After Pafford arrived, I retrieved my vehicle and returned were Warren continued to resist medical assistance. While en route to Pafford base were they would wrap my ankle, Officer Krupin announced on the radio that Pafford needed to return. Once back on scene, I observed Officer Krupin giving chest compressions to Warren.

Warren was transported to the Great River Medical Center where he was later transferred to St. Bernard's Hospital in Jonesboro.

Blood samples were collected at the Great River Medical Center.

An affidavit was filled out on Warren for public intoxication, fleeing on foot, and for failure to submit to arrest.

On 9/29/18 I Officer S. Berumen responded to Walnut St. in regards to an incident Officer Driskill was in. On arrival I observed Officer Driskill and Officer Krupin attempting to detain Rayshawn Warren. I then went and assisted in grabbing Warrens right arm and placing it behind his back while Officer Driskill grabbed his left arm. Warren was clearly under the influence of some kind of narcotic as he was very erratic and would not listen to our commands. Warren was finally held down by Officer Krupin and Officer Driskill was able to secure both arms behind his back. At that point Warren fell unconscious from Officer Krupin's hold and was released and allowed regain consciousness. Because of Warren loosing consciousness Pafford was called to check him prior to him being placed under arrest. Upon Pafford arriving on scene Warren again started to fight and continue to try and leave the area not allowing paramedics to check him. We attempted to restrain his legs as he began to kick violently at us and the paramedics. Once his legs were secure in handcuffs we attempted to find a proper tie to secure his legs to the floor of the vehicle as we did not want to have Warren Kick out a window. I then walked away from Warren and walked to my vehicle to attempt to see if I could contact any Officer in the area with a proper tie down. Upon walking back from my vehicle I observed Warren lying on the floor motionless and the paramedics getting in their ambulance and start to drive away. I asked Officer Krupin if Warren was breathing and checked him for a pulse. I did not feel a strong pulse and advised Officer Krupin to start CPR as I called the ambulance and made sure they did not leave. The paramedics came back on scene and took Warren into there custody transporting him to the Great River Medical. No further incident occurred.

On 09/29/18 I Officer Krupin responded to Walnut street to assist Officer Driskill since he had an unknown subject running from him. Once arriving on scene I observed Officer Driskill laying on top of a black male later identified as Rayshawn Warren. Warren seemed to be under the influence of a narcotic of some kind and was acting very belligerent towards Officer Driskill, Officer Berumen, and myself while we attempted to place Warren in custody. After continuously trying to place Warren in custody I got on his back and attempted to hold him down, while doing so he kept fighting therefore I tightened my grip causing him to lose consciousness. Officer Berumen and Officer Driskill were then able to place Warren in handcuffs; Warren quickly regained consciousness. I then called Pafford do to Warren losing consciousness to check on him. Upon Pafford arriving on scene Warren began kicking and fighting again. Medics then assisted us on trying to control him and determine if Warren needed medical attention. Officer Berumen and myself approached our patrol units trying to find a tie down so Warren wouldn't be able to damage anything inside of the patrol unit. As I re approached Warren I noticed the medics getting in the ambulance and begin to drive away. Officer Berumen walked back and asked me if Warren was breathing as he was lying very still. I tried to find a pulse and see if I could notice any air coming out of his mouth which I couldn't seem to feel a pulse or air so I asked Officer Berumen if he could find a pulse but was also unsuccessful. Officer Berumen began to run down the road and catch up to the ambulance while I started to do chest compressions. Once the medics arrived back on scene we began taking off the handcuffs and placed Warren on the stretcher. Warren was then transported to Great River Medical Center where he was treated.

During my interaction with Warren I noticed that he appeared to have been foaming at the mouth. Warren continued to yell what sounded like random phrases that made no sense. During this incident, Warren had both of his fists clenched tight. .

While attempting to restrain Warren, Officer Krupin applied a hold which caused Warren to lose consciousness. This allowed Officer Berumen and myself time to apply the handcuffs. Pafford was then notified for Warren and myself. Warren regain consciousness and again began to resist. Warren began to kick officers and kicked my body camera from my chest. Warrens feet was secured and he continually attempted to get up and leave.

Pafford arrived at which point I told them to check on Warren first. Warren resisted medical treatment and was restrained from injuring Officers, medical personnel and himself. During this time, I retrieved my vehicle and contacted the shift supervisor.

I returned to Warren and Pafford had control of him. Pafford informed me that they would wrap my ankle at the base and we left the scene. Officer Krupin got on the radio and requested Pafford back to Warren. When I arrived, Officer Krupin was doing chest compressions. Pafford took over and transported Warren to the hospital.




As he looked up, he noticed that Julie was driving the vehicle and she had began to drive faster towards him. He said that she then switched lanes, in an attempt to hit him. Warren said as he jumped out of the roadway, the vehicle mirror hit his back. Warren said he then got up and noticed that Julie had turned the vehicle around and was driving back towards him. Warren then ran and stood behind a tree until she passed. Warren did state that he threw a brick at her vehicle, as she passed, however, he did not know if he hit it or not.

There were no injuries, grass stains, or mud located on Warren. An affidavit was completed at the time I spoke with him.
