THAT THE FACTS TENDING TO ESTABLISH THE FOREGOING GROUNDS FOR THE ISSUANCE  
OF A SEARCH WARRANT ARE AS FOLLOWS:

On September 29<sup>th</sup> 2018 officers with the Blytheville Police department responded to the area of  
910 Hearn St. in reference to a suspicious person knocking on doors. Officers made contact with  
several individuals in the area who stated this unknown male was acting strange and hollering for  
help. Officers made contact with Rayshawn Warren on Main St. in the area of Cobb Funeral home.  
Warren began to run from officers but he was caught after a short foot pursuit. Warren refused to  
be taken into custody and it took several officers to get him in handcuffs. An ambulance was  
contacted and responded to the scene because officers knew something wasn't right with the way  
Warren was acting and they wanted him checked out prior to being transported to the Sheriffs  
Office. Sometime after paramedics arrived Warren stopped breathing and was transported to the  
Hospital. Warren was put on life support and then transferred to St. Bernard's in Jonesboro where  
he remains in a vegetative state. Due to him being unable to sign a medical release form this  
undersigned detective is asking the court to order the release of his medical records for review in this  
case.
