I called 911 at 6:48 p.m. to have an officer meet me at GRMC/Blytheville to report a stabbing. The operator 1st told me to let the hospital call them(911) to have an officer appear. I then stated I'm trying to get a jump on things because I know how slow y'all can be sometimes.

Now, I'm at the hospital to register my child for her stabbing wounds and there's no officer there or pulling up. I call 911 again at 6:53 p.m. and ask why the officer has not appeared at the hospital like I asked. A different dispatcher stated she would get them out there. More words were exchanged I just can't remember them at this time.

So, now it is 6:57p.m. and I call 911 again and the 1st operator I talked to at 6:48 p.m. answered. I asked, why haven't an officer appeared and she placed me on hold. Then she picked up again and said she was transferring me to the Patrol Unit and placed me on hold again. After being on hold for over minute and seventeen seconds (1:17) long I hung up and called the Police Department line direct at 6:58 p.m.

After having no cooperation with the dispatchers of 911 I call the Chief of Police cell number at 7:09 p.m. He asked me to let him get in touch with someone and he will give me a call back. Four minutes (4) later Chief Thompson call my cell and asked me to give the responding officer three or four minutes (3 or 4) to make it to the hospital.

Officer Lively REFUSING to take the report of a runaway 12 hours after the after
and Dispatcher breaking confidentiality with a caller

On Friday, December 5th, at 6:21p.m. I called 911 to inform them of a runaway. The dispatcher told me that was not an emergency situation I must call the station to report a runaway. I then called the station at 6:21p.m., but when the dispatched picked up they did not talk to me she was talking to a male in the background because I heard them talking. I hung up and called again at 6:22p.m., the same dispatched that answered for 911 answered the call. I stated I wanted to report a runaway. I don't remember what question was asked next, but I stated he was heading down Franklin Street. She asked which direction was he walking and I stated south. I then said if an officer comes from that direction maybe they would be able to pick him up and bring him back. I remember stated because the Christmas Parade is going on and he's a fast walker. I was asked what he was wearing. I stated he's wearing a rainbow colored sweatsuit or jumper; and he's about 5'09, 5'10 or maybe 5'11...I don't know I just know he's taller than me. Dark skin, slim built. I also remember tell the dispatcher that he's a fast walker. She then said ok she was sending an officer by. NO ONE CAME TO MY HOUSE.

On, Saturday, December 6th, at 5:59a.m. my husband called and informed me that Butta was over his grandma's house and a police officer took him there. Butta's uncle told him that. They work together. Once I got off the phone with my husband I walked inside the police department where a lady in a green shirt and Office C. Honey was standing in the window. She asked if she may help me and I asked who was the officer that help my son run away from home yesterday and why did no one show to my house to take the report for the runaway? She then got up to get help and Officer Honey stayed and asked me what's the name. And I asked who's name because I

didn't know if he was asking for my name or my son's name. I then said Chevelle Harris. He said, "oh yeah I took him to his grandma house". So then I asked, YOU AIDED A RUNAWAY? He then said he was going to get someone. I don't know the time laps, but Officer St. Lurant and Christopher Honey then can out to talk with me. I then stated I DO NOT WANT HIM (Christopher Honey) HERE he helped my son run away from home. He then said "well bye". I want to press charges on Christopher Honey for aid a runaway I ran the story on how my son ran away from home yesterday and I called the station at 6:21p and gave the dispatch his description and waited on an officer to show and NO ONE SHOWED and how I just found out from the uncle that works with my husband that an officer took him to his grandma house. I don't remember all, but I do remember he asked me where did the grandma stay? And I stated which one...he has 3. He then stated does she stay on Sales? I then said well, there you go...you know more than I do. Don't act as if Honey didn't talk with you before you came out here to talk with me. That is why it took you so long to come and talk with me. I then asked how can an officer aid a runaway in running away from home? He then told me to calm down and I said I can't because one of your officers helped my son run away from home and NO ONE showed to my house to take a report. He then stated to me my son told the officer he did want to be over my house or with me. I can't quite remember what, but it was to the effect that I then stated who was it to him to decide that for a minor, he's not a judge nor you. And if he felt as if he needed to send him there then why didn't he come to my house to find out what the problem was? NO, he took it upon himself to do the total opposite of his job. He then made the statement that he has kids to and he understands. I asked oh...and police officer aided your child to in running away home too? He then left to get the person that's over him. I don't know the time laps again, but then Officer Kyle Lively, walked out and stated to me I will have to complete a Civilian Complaint form and I then stated I will do that Monday, so I know it will make it to the proper place. Officer Lively then stated in the room with two other officers he can do the report until then. I was over the top with frustration after that. There were officers all around and I asked him to say it very clear for me to comprehend. Are you saying to me you are refusing to let me do a report for my child that ran away from home last night even though I called at 6:21p.m., Friday night and reported it and waited on an officer to show and no one ever did to take my report. That I still can't file a report until I do a civilian complaint against Officer Christopher Honey.

NOTE:

Once Office Culp brought my son back to the house. Chevelle stated that while I was on the phone with the dispatch lady he was looking her in her face. She then told him I was on the line reporting him as a runaway.

To end this I want to file charges against Officer Christopher Honey for aided my son to run away from home. If possible the dispatcher, who answered the call, for assisting the runaway as well and breaking confidentiality of a caller.
