The first officer then walked back up to my vehicle and asked did I have someone to get my child I told him my grandmother was on her way. He then put me in handcuffs and put me in the back of the police car leaving my 1 year old daughter unattended. The 2nd officer that came out lit a cigarette and began smoking while on the scene in which I don't allow anyone to smoke around her due to her having asthma + bronchitis. While in the police car I stated I'm glad I know lawyers and the officer told me good because I would need 1 dealing with him. As we were pulling up to the police station I was on the phone with my aunt trying to get her to go to my job. The officer got out of the front scratched my phone and hung it up. As we were in the police station I asked him if I could use the phone to call my job before 10 he told me yes I could when he finished his paperwork. I was never able to use the phone or told what my bond was until 12:45 when I was being transferred to the county.
