Julius Thompson, age 17, was in a witness room alone,
LT. Fraizer went into the witness room and begin telling
my son that (I) his mother, was lying through my
teeth out there on the witness stand and Julius
replied that if he (LT. Fraizer) is on twalker (the victims)
side, then "fuck walker". LT. Fraizer got into my son's

face pointing fingers in his face telling him that he has authority over him and the court and that my son has no authority. My son replied "Bruh, get out of my face", LT. Fraizer replied "I'm not your bruh" and stated that he had a pair of handcuffs for ~~help~~^{him}, at which time he got the handcuffs and cuffed my son. A juvenile officer (female) was present when my son begin crying and getting cuffed. Another officer, Mr. High, entered and asked what was going on. My son was released and given paper towels to clean his face.

FACTS On 12-11-18, I went to Clerk's window, 2nd floor, and spoke to Tinker about getting the search warrant and supporting documents for an Aggravated Robbery case # 2018-01906 that happened in my home being searched. Tinker told me that I had to clear it with Lt. Fraizer before she gave me any paperwork. I asked her why did I have to clear it with him and she said because if the case is still open then she won't be able to give me anything. I knocked on CID's door and spoke to LT Fraizer at the door. (There is a camera on top of the door that supports the conversation). I told him I was asking for a copy of the warrant and any other documents relating to that incident. Tinker had came into the hallway and was getting on the elevator when Lt. Fraizer asked her, why did she tell me to ask him and she replied that she wasn't sure if she could give me anything if the case was still open. Lt. Fraizer told her that the case was closed and that she can only give me a copy of the warrant (or some kind of report that I have a copy of) but not to give me anything else because I need to have my attorney request any other

documents relating to the case. I went ^{back} to the window and Tinker gave me a paper that described what happened @ my residence on the day that the police served a search warrant on the ~~aggravated~~ ^{aggravated} robbery case. (I never received a copy or never seen a search ~~warrant~~ ^{warrant} warrant). Tinker apologized about not being able to give me what I asked for at first. I left the police department and called a friend and told him what happened. He told me about the Freedom of Information Act and told me ^{that} those records are public record and he said I have a right to request those records. ~~My friend~~ ^{My friend} accompanied me back to the police department and we approached Tinker at the window. He asked Tinker why couldn't I request a copy of those records and she told him (and myself) that Lt. Fraizer told her to only give me the ~~paper~~ paper she provided me and that my lawyer could request the rest. ~~My friend~~ ^{My friend} told ~~her~~ ^{Tinker} about the Freedom of information act and how the records are public and ~~that~~ I have a right to request those records. ~~He~~ ^{My friend} told Tinker that she knows I have a right to request the records no matter what Lt. Fraizer said. Tinker pulled out a drawer and gave me a Freedom of Information Act Request Form Letter to fill out and return to request those records. I was provided false information by Lt. Fraizer about my rights to request the information on my own. Lt. Fraizer ~~purpose~~ purposely attempted to make it difficult for me to obtain those public records. Had I not talked to a friend, I would had not known about my right to request the records myself.
