Tell us about your experience I was notified that my son was being unlawfully detained I went to the location in front of his Father's house to get details. I approached the scene an African American Officer asked me to come towards him. I did as he asked. I asked questions regarding my son arrested and he stated he didn't know asked

me with my lights?" I (Davis Martin) responded by saying yes I saw the lights but I knew the sirens weren't for me and my family because we had done nothing wrong. The female officer asked for vehicle documentation along with license and car insurance. We gave the documentation to her as another officer(male) approached. He said how old are those kids? My wife and I still in shock didn't respond due to the fact we were calming our children down. The male officer then stated " how old are those kids?" My wife and I looked at the male officer asking him what is this all about? The male officer then says, all right come on lets go get out of the car. The male officer is now reaching inside of the driver side window which had been rolled down previously while speaking to the female officer. As the male officer is attempting to open our vehicle door my children start screaming uncontrollably. The male officer has now opened my vehicle door without my consent and begins to pull me aggressively from my seat. I then say to the male officer I'm still in my seat belt. Another male officer is standing to initial male officers right side and gives my wife the OK to undo my seatbelt. Once my wife takes my seatbelt off the initial male officer begins to scream stop resisiting, stop resisting, someone get your taser out. He then attempts to grab the taser out of the second male officers hand who gave my wife the OK to undo my seatbelt. I wasn't resisting the officer but complied with them during the entire incident. My children were in their seatbelts, my documentation for my vehicle were given to the initial female officer and verified, my lights work properly, I wasn't fleeing anywhere but merely driving the speed limit from one celebration to another, and I was falsely detained in front of my family on the fourth of July. It was very sad because my wife and I both come from families with strong military backgrounds and to have our family falsely pulled over and to be detained falsely and to have been aggressively handcuffed and threatened with being tasered has deelpy hurt our family emotionally.
